<p>Shall there be issued not exceeding Four Million Seven Hundred and Forty-Nine Thousand Five Hundred Dollars (\$4,749,500) principal amount of Revenue Bonds of Citrus County, Florida, bearing interest at a rate not to exceed the maximum rate permitted by law at the time of the sale of the bonds, maturing not later than Twenty (20) Years from the date of issuance thereof, secured by the pledge of a portion of the Local Government One-Half (1/2) Cent Sales Tax, for the purpose of financing the cost of the acquisition and preservation of fresh-water springs, wetlands and Nature World Attraction known as "Homosassa Springs", more specifically described and provided in a resolution of the Board of County Commissioners of the County, adopted on July 17, 1984.</p>
