


INSTRUCTIONS TO VOTER: HOW TO VOTE YOUR BALLOT CARD



FRONT

STEP 1

Vote only one ballot card at a time. Slip pallot all the way into ray, UNDER clear plastic cover from eft side of machine.



STEP 2

Move the chrome ounch lever so that he red pointer is to he right of the candidate of your choice. Depress the lever vhich will punch out



he cross + in the voting square to the right of the candidate's name. To vote on any proposition appearing on the ballot, PUNCH DUT THE CROSS + in the voting square o the right of the words "FOR" or "AGAINST".

STEP 3

Repeat Step 2 with ach remaining balcard. All listinguishing marks ir erasures are foridden and make the allot void. If you



nake a mistake, tear or deface any portion if your ballot card, replace the card in the lastic ballot envelope and return to the lection official for another ballot.

STEP 4

ifter you have comleted voting, return ne punch head to ne top position. 'lace your ballot ard(s) in the plastic nvelope with the



umbered stub(s) at the top and hand it to ne election official, who shall then in the resence of the voter, remove the numered stub(s). The voter may then personlly deposit the voted ballot(s) in the ballot ox or direct the election official to do so i the voter's presence.
